**Litter Nomination Health**

The BCSA strongly recommends that both the Dam and the Sire of the nominated puppy have all health testing/clearances prior to the breeding. At this time, health testing/clearances of the Dam and Sire are not required to be able to nominate the litter, BUT all health testing/clearances (or lack thereof) WILL BE listed in the Futurity Catalog. Health testing/clearances that the BCSA recommends (but not limited to) are OFA for Hips/Elbows, yearly CERF exam, and DNA testing for CEA/CH, CL, and TNS.
