REQUIREMENTS FOR BCSA FUTURITY

Any purebred Border Collie at least four (4) months of age on the day of the show and meeting the Futurity requirements is eligible for the Futurity Classes. Dogs entered in any Futurity classes need not be entered in any other class. At the completion of the individual class judging, each class winner will be brought back into the ring for awarding Best in Futurity and Runner-Up to Best in Futurity. Only dogs which come from a litter nominated for the Futurity and have been individually nominated for the Futurity are eligible.

CLASSIFICATION FOR FUTURITY

- 4-6 Months Puppy Dog; 4-6 Months Puppy Bitch
- 6-9 Months Puppy Dog; 6-9 Months Puppy Bitch
- 9-12 Months Puppy Dog; 9-12 Months Puppy Bitch
- 12-15 Month Puppy Dog; 12-15 Months Puppy Bitch
- 15-18 Month Puppy Dog; 15-18 Month Puppy Bitch

REQUIREMENTS FOR BCSA MATURITY

Any purebred Border Collie at least 18 Months of age on the day of the show and meeting the Maturity requirements is eligible for the Maturity Classes. Dogs entered in any Maturity classes need not be entered in any other class. AKC Champions of record may be entered in the classes. A winner will be chosen in each Maturity class. At the completion of the individual class judging, each class winner will be brought back into the ring for awarding Best in Maturity and Runner-Up to Best in Maturity. Only dogs which come from a litter previously nominated for a Futurity and have aged out of Futurity or previously nominated dogs that have competed in past national Futurity are eligible to compete.

CLASSIFICATION FOR MATURITY

- 18 Month – 3 Year Dog; 18 Month 3 Year Bitch
- 3 Years and Older Dog; 3 Years and Older Bitch
